

DRE GENERAL INFORMATION

1. **COURSE OUTLINE:** Full program titles and descriptions are available online at www.crockersymposium.com.

3. **REFUND POLICY:** A notice of cancellation must be received by Friday, March 19, 2010 to receive a refund.
4. **METHOD OF COURSE PRESENTATION:** The course is presented live.
5. **COMMISSIONER'S REGULATIONS 3007.05; FORMS OF IDENTIFICATION ACCEPTED:** A participant shall present one of the following forms of identification immediately before admittance to a live presentation of an offering or immediately before the administration of the final examination for a correspondence offering:
 - a. A current California's driver's license
 - b. A current identification card described in Section 13000 of the California Vehicle Code.
 - c. Any identification of the participant issued by a governmental agency or a recognized real estate related trade organization within the immediately preceding five years which bears a photograph, a signature, and identification number of the participant
6. **COURSE DESCRIPTION:** The Crocker Symposium is the premier conference in Southern California focused on both the legal and business aspects of real estate, offering sophisticated discussions on the evolving real estate market conditions. The course will consist of two plenary sessions and four concurrent breakout sessions, with each concurrent breakout session offering three different breakout session topics for attendees to select. All attendees must attend the two plenary sessions and four breakout sessions for a total of six sessions. The speakers for all sessions are well-respected and established real estate professionals who will focus on important real estate issues in today's market conditions.
7. **DATE AND LOCATION:** March 23, 2010 at the Los Angeles Convention Center.
8. **CONTINUING EDUCATION CREDIT AND ATTENDANCE:** A registrant who attends 90% of the program during the day and passes the final exam will receive 6 DRE credit hours. Sign-in and sign-out sheets will be available at the registration table (you will need to show government or real estate trade association picture ID when you sign in or sign out). In addition, monitors will check the identification of DRE registrants prior to each session. Anyone who is not present 90% of the time will not be eligible to receive DRE credits.
9. **COURSE CATEGORY AND APPROVED HOURS:** Approved for 6 Consumer Protection hours.
10. **FINAL EXAMINATION:** Students will need to pass an open-book final examination with a minimum passing score of 70%. The exam will consist of 5 true/false questions per session attended by the student. A student must attend the two plenary sessions and four breakout sessions for a total of six sessions and 30 true/false questions. Students will be allowed one minute per question to complete the exam. The maximum amount of time to complete the final exam is 30 minutes. The final score will be determined by the aggregate total of the 30 questions.
11. **FINAL EXAMINATION TEST PROCEDURE:** Students will take the final exam in a proctored room setting at the conclusion of the symposium. Each plenary session and breakout session will have their respective sheet of test questions, each sheet containing 5 true/false questions. Students will receive the test question sheets based on which plenary session and breakout session they attended and will be verified based on the attendance sheet. The Final Exam will take place at 4:45 PM after the completion of the symposium.
12. **COURSE COMPLETION CERTIFICATIONS/RECORDS:** Course completion certificates will be issued after completing the course and successfully taking the final exam. Records of course completion will be maintained for a minimum of five years.
